All the Divisional Managers are informed that the annual plan for schedule of inter ploughing in all raising & maintenance plantations (EPs/BPs/Misc.) without forming gullies including post harvesting plantations (I,II&III rotations) as per schedule of operations/FSR during 2023-24 are as furnished below. Further they are informed for taking necessary action accordingly without deviation under any circumstance and record in the MB with proper check measurement, keep the floor clean & neat and also protect from the fire accidents/cattle damage etc.,. Funds may be released as per agreement executed after check measurement / progress report time to time and report compliance.


